7. **Dance attire and hair:**
  - Ballet Classes Black leotards, tan or pink tights, and pink ballet shoes are required for all ballet classes. Hair should be pulled up in a bun.
  - Jazz and lyrical classes must wear dance attire that fits tightly. No loose fitting shorts or shirts. Wear appropriate shoes and tights. Hair must be pulled back and secured off face.
  - Hip-hop, clogging, and tap classes may wear loose fitting shorts, and t-shirts with appropriate shoes. Hair must be pulled back and secured off face.
  - Pre-Dance classes should wear dance attire, tights, and appropriate shoes with hair pulled back secured off face.
